Motion by Hays; seconded by Rebhuhn to approve the 2007-08 AC-T Student Handbook. Motion carried (4-0).

Motion by Rebhuhn; seconded by Clausen to amend the following policies by adding sexual orientation and gender identity as protected classes: 102 – Equal Educational Opportunity; 302.1 – Superintendent Qualifications, Recruitment, Appointment; 303.2 – Administrator Qualifications, Recruitment, Appointment; 405 – Licensed Employees Qualifications, Recruitment, Selection; 411.2 – Classified Employees – Qualifications, Recruitment, Selection; 500 – Objectives for Equal Educational Opportunities For Students; 600 – Goals and Objectives of the Education Program; 603.4 – Multicultural/Gender Fair Education. Motion carried (4 – 0).

Motion by Hays; seconded by Clausen to amend Policy 401.1 - Equal Employment Opportunity to comply with new requirements for protected classes and mandatory background checks. Motion carried (4 - 0).

 $Motion \ by \ Clausen; \ seconded \ by \ Hays \ to \ adopt \ Policy \ 104-Anti-Bullying/Harassment \ Policy. \ \ Motion \ carried \ (4-0).$

Motion by Rebhuhn; seconded by Hays to affirm Policy Series: 410 - Other Licensed Employees. Motion carried (4 - 0).

Motion by Rebhuhn; seconded by Hays to accept the resignation of Doris Lovin, nurse, effective immediately, with appreciation for her service to the children of AC-T. Motion carried (4 – 0).

Motion by Hays; seconded by Rebhuhn to increase the mileage reimbursement rate from 25 cents per mile to 30 cents per mile. Motion carried (4 – 0).

Motion by Clausen; seconded by Hays to approve a summer school program as proposed. Motion carried (4 – 0).

Motion by Rebhuhn; seconded by Hays to recommend the following as the five legislative priorities of the Albert City-Truesdale CSD: 1) Supports extending the school infrastructure local option tax to a statewide penny sales tax distributed on a per pupil basis, recalculated annually to adjust the statewide average revenues per student; 2) Supports setting allowable growth at a rate that encourages continuous school improvement and reflects actual cost increases experienced by school districts. The allowable growth rate should be set no lower than 6 percent; 3) Supports a meaningful budget guarantee for school districts with declining enrollment and real on-time funding for districts with increasing enrollment in the current year; 4) Supports funding to ensure that all three and four year olds have access to a high quality public school program to be funded by including preschool students in the enrollment count with revenues that do not divert what would otherwise be K-12 resources. Funding should be allocated for literacy-based programs with well-articulated standards of high quality; 5) Supports building on student and tax payer equity investments begun during the 2006 Legislative Session, ensuring they are fully funded and become part of the foundation formula for stability. Motion carried (4 – 0).
